CORPORATE PERSONNEL CIRCULAR NO. - 1/2011

Subject:-Withdrawal of Austerity Measures - reg.

As a part of austerity, certain measures were implemented in AAI vide letters dated 29.6.2009, 2.7.2009, 22.7.2009, 19.3.2010 and 8.4.2010. The position was subsequently reviewed and some of the entitlements were restored vide order dated 28.5.2010.

2. It has now been decided to withdraw the austerity measures and restore the entitlements as noted below with effect from 1.1.2011:

<u>S.No.</u>	<u>Existing measures</u>	<u>Revised measures</u>
1	Hotel accommodation is restricted to one grade below the present entitlement except the lowest category of executives.	Restored as per entitlement of the executives prior to the introduction of austerity measures.
2.	Sponsoring of executives and Non-executives for training within India is restricted to such programmes where participation fee is Rs.5000/- and below.	Executives, may be sponsored to training programmes within India as per DOP.

3	On transfer, the executives who are entitled (for baggage allowance) to avail double container or 12000 kgs have been restricted to one single container or 6000 kgs by train.	It will be restored as per entitlement of the executives prior to the introduction of austerity measures.
4	Employees are allowed to avail the Leave Encashment only upto 60 days in a year.	It will be restored for employees as per the provision and entitlement prior to the introduction of austerity measures.
