Office Order

Further to this Office Order No. PERS/MPP/1106/27/78(pt)/770 dated 11th October 2000, it has been decided to revise the Honorarium for External an Internal faculty for the training programmes at NIAMAR, New Delhi; CATC, Allahabad; FTC, Delhi; FSTC, Kolkata and Regional Training Centres as per following rates with immediate effect.

A. Scheduled/Non-Scheduled Training Programmes:-

I. External Faculty

S.No.	Category	Rate of Honorarium
1	Sr. Consultant/Professor/Jt. Secretary/ Executive Director & above	Rs. 2000/- for 90 minutes session Rs. 3000/- for two sessions in a day
2	Associate Professor/Consultant/ Dy. General Manager and above	Rs. 1250/- for 90 minutes of session Rs. 2000/- for two sessions in a day
3	Consultant/below Dy. General Manager level	Rs. 750/- for 90 minutes of session Rs. 1250/- for two sessions in a day

The External Faculty will also be entitled for reimbursement of conveyance charges upto and maximum of Rs. 1000/- based on distance.

2	Sr. Manager & Above	Rs. 750/- for 90 minutes session Rs. 1000/- for two sessions in a day
3	Others	Rs. 500/- for 90 minutes of session Rs. 750/- for two sessions in a day
