Corporate Personnel Circular – 15/2010

**Subject:-Weightage for questions during written
examination for recruitment**

The issue relating to weightage for questions on various subjects during written examination for recruitment to various disciplines has been reviewed and it has been decided as follows:

- (i) For recruitment to professional categories, i.e., CNS, Electronics, Finance, Engineering, Law, Equipment, Architecture and CP&MS, the weightage shall be as follows:
- (a) 70% questions on subjects relating to educational qualifications prescribed for the post; and
- (b) 30% on General Knowledge, General Intelligence, General Aptitude, English etc.

(ii) For recruitment to all other categories including ATC, the weightage shall be as follows:

- (a) 50% questions on subjects relating to educational qualifications prescribed for the post; and
- (b) 50% on General Knowledge, General Intelligence, General Aptitude, English etc.

2. All other existing conditions in the R&P Regulations 2005, as amended from time to time, will remain the same except to the extent modified above.

3. In case of any doubt as to interpretation of the aforementioned provisions of this order, clarification shall be obtained from CHQ only which shall be final and binding.

4. The above decisions may be given wide publicity among employees through circulation, website, notice boards etc.

5. The above decisions will come into force from the date of issue of this order.
