Subject:- Exemption to women candidates from  
payment of fees for recruitment

The matter relating to grant of exemption to women candidates from payment of fees for direct recruitment/departmental competitive examinations/direct recruitment through interview has been considered in the light of the relevant instructions of the Department of Personnel and Training letter No.39020/03/2009-Estt(B) dated 15th July, 2009 (copy enclosed), which was also endorsed to the Department of Public Enterprises and it has been decided to grant exemption to women candidates from payment of fees for direct recruitment/departmental competitive examination/direct recruitment through interview to any post in the Authority.

2. All other existing conditions in the R&P Regulations 2005, as amended from time to time, will remain the same except to the extent modified above.
