**Sub : Coverage under EPF & MP Act 1952 – Extension of date of option upto 17.08.2009.**

Sir,

Reference is made to CHQ letters of even number dated 03.10.2007, 17.10.2007, 05.05.2008, 25.07.2008, 15.9.2008 & 04.11.2008 (these letters are available on website i.e. [www.aai.aero](http://www.aai.aero) under 'Pension Scheme') wherein the salient features of the Employees Pension Scheme 1995, option to be furnished by the employees etc. were intimated.

2. The options (i.e. 'A or B') received from the employees on or before 08.08.2008 along with other employee details are compiled and displayed / available on website of AAI ([www.aai.aero](http://www.aai.aero) (AAI Employees → Pension Scheme → Details of Employees → Date Nov-4-2008 (Revised))).

3. As you are aware that the salient features of the Pension scheme was communicated / intimated vide our letter dated 03.10.2007. In the meanwhile, there are amendments to the Employees Pension Scheme 1995 effective from 26.09.2008 which inter-alia provide deletion of few benefits such as commutation, return of capital etc. (The amended Employees Pension Scheme 1995 is available on the website [www.epfindia.gov.in](http://www.epfindia.gov.in)).

4. In view of the above mentioned amendments, requests have been received from the employees to change the option exercised earlier. Since the data is being submitted to the PF Authorities shortly, it has been decided to allow the employees to change the option, if they desire so, as a final opportunity, on or before 17.08.2009. A copy of the application is enclosed as Exhibit-I.

It is reiterated that the employees whose applications are not received by 17.08.2009 at CHQ, shall be presumed to have opted the option as shown on website of AAI (as mentioned at para 2 above). The employees who have not submitted any option so far, they deemed to have opted for option 'B' (i.e. contribution as per ceiling prescribed in the Act, currently it is Rs.6500/-) without any further notice/communication.

5. It is informed that the EPF & MP Act 1952 and the Schemes thereunder viz EPS 1995 is central legislation and Govt. may review / revise any provisions of the Act / Scheme. It is further informed that the Act/Scheme has extensive coverage/application and more than 4.5 lakh establishments with 4 Cr. (Approx.) persons are covered under the Act/Scheme.

6. It is emphasised that no change of option is permissible under the Act / Scheme after the details are furnished to PF Authorities. The details of the employees (who were on the rolls of AAI as on 22.08.2007 and continue to be on rolls as on date similarly those who are separated from AAI after 22.08.2007) along with options are being submitted to PF Authorities in 3<sup>rd</sup> week of August 2009 . **Hence employees are requested to adhere to the last date of receipt of options at CHQ by 17.08.2009.**
