

They are required to assume the charge of new post positively by **15/07/2011** failing which it will be presumed that they have refused the promotion and they will be debarred for a period of two years without any further intimation.

The Promotions being ordered are provisional and are subject to review on the basis of decision of the AAI on the recommendations of the inter-se-seniority committee.

These promotions shall be further subject to the final outcome of the writ petition No.1662/2008 in terms of the order dated 11/08/2008 passed by the Hon'ble High Court of Delhi.

They will be under probation for a period of one year from the date of joining.
