Sir,

Consequent upon handing over of IGI & CSI Airports to the respective JVC as a part of restructuring and modernisation process, the employees of AAI posted at IGI & CSI Airports are to be deployed to other airports.

2. In the above context, requests have also been received from the employees posted at other establishments at New Delhi & Mumbai for transfer to the Airport/location of their choice due to their personal reasons.

3. In view of the above, it has been decided to consider the transfer requests of the employees from the establishments of AAI at Delhi and Mumbai to any other Airport/location of their choice as a special case. The above transfers would be treated as in public interest and the employees would be entitled for normal TA/DA and joining time.

The last date of receipt of application is 30.03.2009.
