**Subject : Expeditious Implementation of Orders dated 1<sup>st</sup> February, 2010  
in respect of Non-Executives**

Please refer to the two orders issued on 1<sup>st</sup> February, 2010 amending / clarifying the R&P Regulations, 2005 as amended from time to time, in respect of non-executives.

2. In the meeting with the representatives of the Employees' Union held on 17<sup>th</sup> March, 2010, the need for expeditious implementation of these orders was discussed. It has been decided that these orders should be **implemented by 31<sup>st</sup> March, 2010.**

3. It is clarified that these orders already provide that all other existing conditions in the R&P guidelines will remain the same except to the extent modified by these orders. As such, all other conditions including the benefit of reservation in promotion for SC/ST etc., wherever applicable, shall be allowed while implementing these orders.

4. As already mentioned in the said orders, if any clarification is required, the same shall be obtained from the CHQ which shall be final and binding. For this purpose, communication, if any, may be addressed to **ED(Pers.), CHQ by fax latest by 22.03.2010** so that these orders are implemented before 31<sup>st</sup> March, 2010.
